

Strategic Intentions 2024/25 - Digital Executive Board

Objective

The overall objective of the Digital Executive Board (the Board) is to drive and lead a wholeof-system approach to transform digital public services and support digitisation and integration of public services around common citizens, clients, and customers.

Membership

The Board's membership includes the following Chief Executives from within the Board's remit:

- Department of Internal Affairs Secretary for Internal Affairs | Te Tumu
 Whakarae mō te Taiwhenua (Government Chief Digital Officer).
- Statistics New Zealand: Government Statistician | Te Tumu Whakarae mõ
 Tatauranga Aotearoa (Government Chief Data Steward).
- **Te Kawa Mataaho Public Service Commission**: Public Service Commissioner | Te Tumu Whakarae mō Te Kawa Mataaho (Head of Service).
- Inland Revenue: Commissioner of Inland Revenue | Kaikōmihana o Te Tari Taake (System Lead Service Transformation).
- Government Communications Security Bureau: Director-General of the Government Communications Security Bureau | Te Tumu Whakarae mō Te Tira Tiaki (Government Chief Information Security Officer).

The Department of Internal Affairs is the servicing department for the Board. The Chief Executive for Department of Internal Affairs Te Tari Taiwhenua is the Chair.

Scope of role and functions

The Board is responsible to the Minister Digitising Government.

The Board will drive and lead a whole-of-system approach to transform digital public services. The Board is accountable for supporting the digitisation and integration of public services around common citizens, clients, and customers by:

- Leading and managing the whole-of-system transformation of digital public services, including producing and implementing a system Roadmap for digital public services that enables clear sequencing and prioritisation of investment.
- Joining current work programmes at key points of overlap to build on progress already being made across the public service.

The Board member also have accountabilities as a departmental Chief Executives that include, but are not limited to:

- Stewardship and strategic direction
- Resources
- · Performance of the Board and secretariat
- Legislative compliance

Individual Chief Executives will retain sole accountability for the performance, operation, and actions taken by their agencies when carrying out their individual or system role and functions. They will also continue to be responsible for the fiscal management and the financial sustainability of their agency.

Functions that support the Board's priorities

The Board will undertake the following to support these strategic intentions:

- Meet regularly to discuss issues and opportunities to progress.
- Receive reporting on progress on the Service Modernisation Roadmap and new new approach to digital investment.
- Advise the Minister on progress made against the work programme to implement for the Service Modernisation Roadmap.
- Support and advise the Digitising Government Ministerial Oversight Group.

The Board's initial priority is to support the progress of Service Modernisation Roadmap, digital investment approach, and associated work programme.
